## 3. Summer months / Winter months

The sum of charges for the winter months January, February, March and October, November, December corresponds to ca. 55 % of the annual service fee; the sum of charges for the summer months April, May, June, July, August and September corresponds to ca. 45 % of the annual service fee. This applies correspondingly to the days of the individual months.

The seasonal factor will not be applicable to the accounting and measuring fees, the Biogas levy and Quality Conversion charges.

# 4. Calculation process and application of multipliers

Capacity fees for capacity contracts are based on the sum of the daily fees stated under items 1 and 2, multiplied by the respective booked capacity and by the multiplier stated below for all days in the billing period.

Within-Day capacity products are priced just like daily products, independently of the duration.

Applicable multipliers for short-term products:

Product	Multiplier
Within-Day product	1.4
Daily product (runtime between 1 and 27 days)	1.4
Monthly product (runtime between 28 and 89 days)	1.25
Quarterly product (runtime between 90 and 364 days)	1.1

Multipliers are not applied to accounting and measuring fees, the Biogas levy and the Quality Conversion charge.

# 5. Dues

The tariffs stated above are net of charges. Dues and taxes, e.g. value added tax, shall be paid by the shipper in addition.
